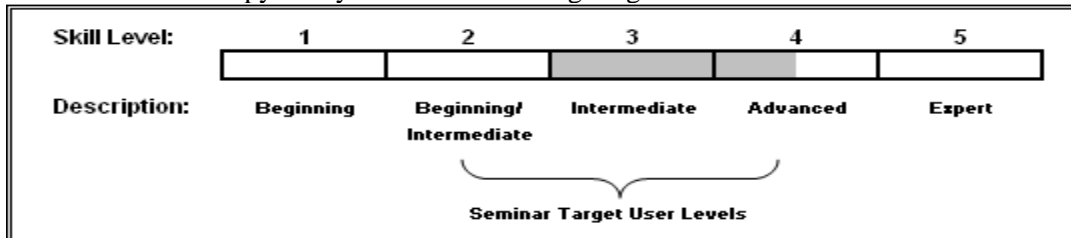


Excel Tips and Techniques for Increased Productivity and Improved Financial Modeling - *ADVANCED*
